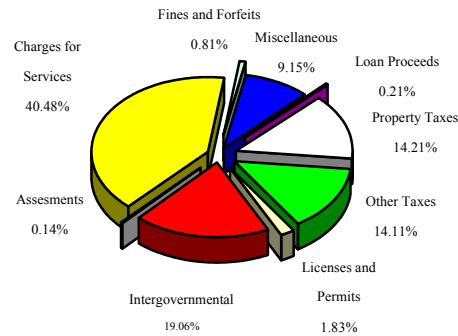

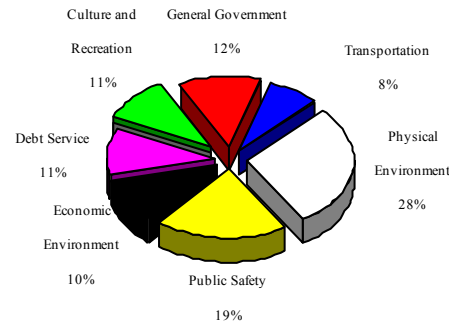

# OPERATING BUDGET HIGHLIGHTS

- Continues the implementation of objectives leading to the attainment of City Goals including the revitalization and strengthening of the downtown and neighborhoods.
- Provides a 0.0873 millage decrease for taxpayers not in the St. Armands Business Improvement District (BID).
- Initiates the St. Armands BID by providing an additional 2.0 mills, which results in a net millage increase of 1.9127 for taxpayers within the St. Armands BID.
- Provides \$58,808 for the creation of a Human Relations Board as mandated by a Charter referendum including an Administrative Specialist II.
- Provides \$45,769 for a Human Resource Analyst I for labor relations training and development
- Provides \$28,922 for a receptionist at the new Federal Building.
- Provides \$235,000 for retrofitting the City Hall air conditioning.
- Provides \$1,622,422 in increased contributions to the Police Pension Fund as necessitated by significant stock market declines.
- Provides \$800,000 for contributions to the Fire Pension Fund as required by a new Interlocal Agreement between the City and Sarasota County effective October 1, 2003.
- Provides for a general salary increase for all employees.
- Provides \$727,800 for increased funding for employee and retiree medical insurance.
- Provides \$145,882 for additional landscape maintenance including 3 Landscape Technicians for newly opened parks and Main Street streetscape.
- Provides \$177,009 for increased Street and Highway expenses including an Electrician, an uninterruptible power source, additional sidewalk pressure cleaning, utility services and maintenance of Public Art.
- Provides \$51,000 for increased Engineering costs for beach renourishment & lobbying, Beach Watch, travel for grants, and transportation software.
- Provides \$51,371 for the operation of the Skateboard Park scheduled to be open in 2003-04.
- Provides for the "freezing" of twelve positions including an Administrative Specialist II in the City Manager's Office, a Public Information Officer, four Community Resource Officers, five Neighborhood Enforcement Officers, and one Neighborhood Enforcement Sergeant.
- Projects the General Fund fund balance at 17.04% of budgeted expenditures.
- Includes a 2% increase in water and sewer rates effective 9/1/03. This computes to \$55.17 (including excise taxes) per month for a single-family residence using 5,000 gallons of water.
- Provides for no increased fees at the Bobby Jones Golf Complex for 2003-2004.
- Provides a \$488,300 subsidy to the Van Wezel Performing Arts Hall.
- Provides a \$614,968 subsidy to the Sports Stadium.
- Sufficient tax increment revenues will be generated to pay for debt service, to help fund the Redevelopment Office and to fund development incentives, and some Downtown Master Plan projects.
