## LAW ENFORCEMENT DEATH BENEFIT

**Description**

Florida Statute 112.19 governs death benefits payable to law enforcement officers killed in the line of duty. This program provides a benefit of up to \$150,000, adjusted for price level changes, for sworn law enforcement officers that are "accidentally" or "intentionally" killed as a consequence of performing their duties. The current maximum benefit, including the price level adjustment mention above, is \$179,083. The City is fully self-insured for this benefit.

The City procures stop-loss insurance coverage for individuals with annual claims between \$200,000 and \$1,000,000, annually.
