CITIZEN INPUT IS WELCOME DURING ALL HISTORIC PRESERVATION BOARD MEETINGS WITHOUT PRIOR NOTICE. CITIZENS MAY ADDRESS THE BOARD ON ANY TOPIC THAT IS NOT ALREADY ON THE AGENDA FOR A TOTAL OF 3 MINUTES. CITIZENS MAY ADDRESS THE BOARD DURING PUBLIC HEARINGS AND TIME LIMITS ARE ESTABLISHED BY BOARD MEMBERS.
