## WHAT IS THE UTILITY DEFERRED PAYMENT ASSISTANCE PROGRAM?

The program offers a 3.07% interest deferred payment loan to pay for capacity and connection fees and associated costs for hooking up to Sarasota County's central water and/or sewer services when mandated under Sarasota County Code, Section 126-58, Connection to the Sarasota County Utilities System.

Eligible costs include:

- Payment of capacity and connection fees
- Plumbing fees
- Well abandonment
- Septic tank abandonment
- Backflow preventer

### HOW WILL THE LOAN BE REPAYED?

Repayment is not required until the property is sold, transferred, no longer owner-occupied, or 20 years.

### ELIGIBILITY REQUIREMENTS

- Home must be located in Sarasota County.
- An existing homeowner seeking water and/or sewer hookup assistance for their primary residence with a value not exceeding \$200,000. If the property has an accessory dwelling, the value may not exceed \$240,000.
- All homeowner applicants must be current on their property taxes and existing mortgages.
- Water and sewer connection must be completed within three months of the application approval.

- Total household income must be at or below the income limits shown on the below table as adjusted by household size.
- All work must be performed by a licensed trade.

### INCOME LIMITS For Sarasota County

The chart below lists maximum eligible gross incomes adjusted to household size:
